The following documents are **REQUIRED** (where applicable):

- Written Personal Statement from applicant which provides all pertinent circumstances for the request.
- Applicable Medical Documentation including written and dated Clearance to resume playing rugby from a Medical Professional.
- Documents which verify reasons for geographic relocation; letter from employer which includes terms (start date, location, salary) of the employment; admission notification from institution; materials confirming geographic relocation such as copy of lease agreement, personally addressed mail at new location, government issues identification and/or license, etc.
- Additional contemporaneous documentation relevant to the Request.
- Transfers Only: Confirmation of In Good Standing with the former **Club** (no disciplinary or financial issues). *(Transfers only!)*
- Transfers Only: Confirmation of In Good Standing with the former **Approved Governing Body** (no disciplinary or financial issues). *(Transfers only!)*

As stated in the eligibility regulations:

- Waivers will only be considered when submitted by a player who has met the CIPP Registration deadline; and
- Mid-season transfer requests must be submitted with a statement of release from the original club and/or Approved Governing Body.

The Eligibility Committee will have up to ten (10) days from date of receipt to provide an Eligibility Decision. Cutoff for consideration is five (5) business days prior to the event for which eligibility is requested with a required **\$50 expedite fee**.  
*Waivers are not accepted less than 48 hrs before an event.*
